## How to Retrieve Voter Registration Data from the Colorado Secretary of State

1. Ctrl + Click on this link: [www.govotecolorado.com](http://www.govotecolorado.com). This will take you directly to the Secretary of States website.
2. Under “View or update my voter record” click on “Find my registration”.
3. Enter the following required information:
4. Under “Name” enter your first name under “First”.
5. Enter your last name under “Last”.
6. Under “Zip” enter the zip code where you are registered to vote.
7. Under “Birthday” enter your date of birth in this format mm/dd/yyyy.
8. Click on the white box next to, “I’m not a robot”.
9. Click on the blue “Search” button below the I’m not a robot” box.
10. Under “Voter Details”, under “Registration” locate “Voter ID” and write it on the request form.
11. Under “County registration date, write that date on the “Voter Registration Date in Colorado” line on the request form. This will also provide you with your “Party Affiliation” and your “Date of Affiliation”.
12. On the same line as “Voter Details”, click on “County & District Information”.
13. Right under “District Information”, “Precinct” and a 10-digit number is listed. This number is your Precinct Code. Write that number on your request form. This is what the precinct code means per the Secretary of States Office:

Example: 2082654002

2 = Congressional district  
08 = State senate district  
26= State house district  
54 = County Code (54 = Routt County)  
002 = Precinct number
